1. (hereinafter refers to as 'THE TRUSTEES' which expression wherever the context so requires or admits shall mean and include their legal heirs, successors, executors, administrators and assigns of the SECOND PART.

WHEREAS THE AUTHOR / FOUNDER TRUSTEE above named have been desirous of creating and establishing an educational and a charitable trust under Indian Trust Act, 1882.

AND WHEREAS AUTHOR / FOUNDER TRUSTEE above named has settled a sum of Rs. 11,000/- (Rupees eleven thousand only) as a fund,

AND WHEREAS AUTHOR / FOUNDER TEUSTEE above named has settled the assets and properties mentioned in the schedule hereunder,

In favour of the TRUSTEES upon trust with a view to give effect to his desire of creating and establishing a trust for the purpose of running of Schools,Collegs,Universities,ITI,management cources/Training and others Educational Charitable activities for the benefit of the public, for the objects set out in this trust deed and for fulfillment of which, the terms and conditions are more particularly set out hereunder.

AND WHEREAS THE TRUSTEES named are willing to accept the office of the trustee for the purpose of carrying out the wishes of the AUTHOR /FOUNDER TRUSTEE of the trust under the provisions and directions set forth herein, so as to enable to pursue its objects.

THIS INDENTURE WITNESSETH AS FOLLOWS

- 1) The AUTHOR/FOUNDER TRUSTEE above named hereby establishes a public charitable trust by the name of PRAYAS EDUCATIONAL AND CHARITABLE TRUST for running Educational institutions under the aegis of trust and up on the other conditions set forth hereunder.
- 2) The TRUSTEE named above shall be the first trustees and have given their consent to be appointed as the trustees and as token thereof, they have set their hands to this instruments.
- 3) The AUTHOR/FOUNDER TRUSTEE hereby conveys, transfers and assigns to the TRUSTEES the above referred sum of Rs. 11,000/- (Rupees Eleven Thousands only) as corpus to the TRUST, the receipt of which, the TRUSTEES do hereby admit and acknowledge

- 4) The AUTHOR /FOUNDER TRUSTEE of the trust hereby conveys, transfers, assigns to the TRUSTEE the assets and properties mentioned in the Schedule hereunder, the possession of which the trustees hereby admit and acknowledge, to have and to hold the same in trust as corpus of trust, to be used by the trustees to carry out and fulfill the objects of the trust set forth herein , and the FOUNDER TRUSTEE of the trust hereby relinquishes for all time any claim to or interest in the said assets and properties or fund forming the subject matter of the trust.
- 5) The regd. Office of the trust for the time being shall be situated at Near Shri G-Stonex, Bye pass Road, Solan, Himachal Pradesh-173213, India, with the power given to the trustees to shift the same to any other place as they may mutually agreed upon.
- 6) The TRUSTEE do hereby agree that they shall hold and stand possessed of the said trust assets, properties and funds (Which expression shall include all investments in cash or kind or in any nature whatsoever into and for which ,the said property or part or parts thereof may from time to time be converted, varied or exchanged) and /or such investments as may be held by the TRUSTEES from time in relation to there presents together with all income, additions and accretions thereof, upon trust for the object set out herein with and subject to/the provisions and conditions hereinafter contained in these presents.

**AIMS AND OBJECTIVES OF THE TRUST :-**

- 7) THAT the trust has been created for the objectives of the public educational activities on Charitable basis and charities without references to any of caste, religion ,creed or sex and the trust shall carry on educational and charitable activities at any place within territory of Himachal Pradesh and Pan India, in such manners as the trustee for the time being may think for or to promote international welfare or for the fulfilment of the objectives of the trust:- Following shall be the objectives of the trust:-

TO ESTABLISHING AND RUNNING EDUCATION INSTITUTION

(i) Running and establish of Schools,colleges,Universities,institute for providing hotel management and hospitality courses Training and .

(ii) Running and establishment for opening institutions, university for providing education in food technology ,bio-technology, scientific / marketing research , Foreign language , skills development , tourism , student exchange program under stream / course , eco Hotelism , Eco tourism , pharmacy , law , management , science ,Engineering , Nursing ,vocational and other technical institutions for the benefit of the public.

(iii) Further providing for grants , scholarships , fellowships and other forms of financial assistance to the needy and deserving students for pursuing education, vocational training , skill development etc.

(iv)Granting of financial assistance to any educational institution for granting scholarships , prizes ,medals awards for excellence in studies , sports and scientific research , distribution of books and note books for poor and deserving students .

v) By organizing Educational seminars, workshops and retreats, worship with music for all people to disseminate knowledge etc.

vi) By undertaking completion, printing and publication of books, Journal, Pamphlets booklets, banners and other written material and also production of audio and video aids and other such allied subjects for distribution.

(b) TO PARTICIPATE IN SOCIAL WELFARE ACTIVITIES

i) Help the poor widow or orphans and handicapped person, destitute and other needy person in cash or kind for their maintenance for education.

ii) By organizing Educational seminars, workshops, Competition, Training Programme in regard to Tourism, Environment, Rural Development etc. through on line or offline.

**8) TO ACHIEVE THE ABOVE OBJECTIVES**

- i) By doing all that is necessary and conducive to achieve the objects for which the trust is being established and other such objects which are consistent therewith.
- ii) To do all such acts or things as shall be in keeping with the objects of the Trust and to do all such other lawful things as shall further forgoing objects or any of them, provided such things or acts be not contrary or inconsistent with the spirit and principles of the laws under which the Trust has been organized and registered.
- iii) To do all acts and things incidental to achieve any one or more than one objective including to buy land with or without building, to built or acquire building premises, hospital, schools, colleges, universities, experimental and research center , to take on lease any building and land to mortgage, sell or otherwise raise funds against security of such land and building from Banks, Financial Institutions and raise Unsecured Loans for the purpose and carry out incidental activities like plying of buses ,motor car and other conveyance for achieving the purpose of educational activities ,to acquire machinery and other Fixed Assets and to do all other act and things to achieve objectives as the circumstances may warrant and trust can take building on rent to run any institution etc.
- iv) If any of the objects of the trust or any other provisions contained in his deed of trust is inconsistent with the character of the trust as the public charitable trust , under the provisions of law and regulations regarding to public charities or under direct taxation laws relating to exemption of such public charitable trust ,now or as may be amended from time to time , such object or provisions shall stand omitted or modified so as to be consistent with such laws . All activities of the trust shall be carried out in India .

9) **FUNDS** The Trustees may accept donations, grants, subscriptions, aids or contributions from any person, Government, Local authorities or any other charitable institutions, in cash or in kind including immovable property without any encumbrance, but the Trustees shall not accept any receipt with any condition or terms inconsistent with the objects of the Trusts. While applying such receipts to the objects, the Trustees shall respect the directions, if any, by the granter. Any receipt with specific direction to treat the same as part of the corpus of the Trust or separate fund shall be funded accordingly.


10) **INVESTMENTS**

- i. All monies, which shall not immediately required for current needs shall be invested by the Trustees in eligible securities and investments, or in banks. Such investments shall be in the name of Trust or Trustees.
- ii. That the trustees shall invest the trust fund, carry on any business with the trust fund and/or enter into partnership on behalf of the trust, as they may deem fit.
- iii. That the trustees shall manage the trust fund and investments thereof as a prudent man would do the same. They shall recover all outstanding's and meet all recurring and other expenses incurred in the upkeep or management thereof.
- iv. That the trustees shall receive and hold the income of the trust on behalf and for the benefit of the beneficiaries under the trust.

11). **BENEFICIARIES OF THE TRUST:**

- i) The trust is established for the benefit of citizens of India and the class of people mentioned above without discrimination of caste ,religion, creed or sex

12) APPOINTMENT AND NUMBERS OF TRUSTEES

1) The Trust will be managed by a Board of Trustees consisting of not less than 4 trustees and not more than 9 trustees . The parties of the Second part will be First Trustees and they shall automatically form the Board of Trustees.


a) The first FOUNDER TRUSTEE/MANAGING TRUSTEE will hold office for his life time. After the demise or relinquishment of office of the Managing Trustee or in the event of the First Managing Trustee falling to nominate his successor in office ,the remaining trustees should elect one of the other Trustees as Managing Trustee . the term of office of First Trustee shall be for their respective lives .

The Board of Trustees shall have the power to increase the total number of Trustees up-to the maximum number stated above and fix their terms as per provisions contained herein .

b)Any Trustee, including the Managing Trustee may retire from the Trusteeship hereof by giving two calendar months notice in writing of his or her intention to do so, o the Board of Trustees and after the expiry of the period of notice , the Trustees giving the notice shall ipso facto cease to be a Trustee of these presents .Any vacancy caused by the resignation of any of the Trustees, may be filled up by co-option by the Board of Trustees.

c)The Trustees who are not First Managing Trustees shall hold office for a period of one year from their date of appointment by the Trustees . At the end of this one year period, the Board of Trustees may reappoint them for subsequent term or appoint other persons as Trustees in such a manner that the total number of Trustees does not exceed the approved maximum number of trustees.

d)The Managing Trustees shall have the power to remove a Trustees Suffering from physical or mental disability or if he is accused of misfeasance of trust funds or property or misconduct, after satisfying himself on enquiry and such action of the Managing Trustees shall be final.

2) The proceedings of the Board of Trustees shall not in any way be invalidated due to any post or posts remaining vacant. During the time when a vacancy is yet to be filled up, the remaining Trustees shall act as "Full Board", subject to the presence of Quorum in the meetings. Any vacancy in the Board of Trustees or illegality in the appointment of Trustees or their proceedings shall not invalidate any prior act or decision of the Board.

**3.POWER OF TRUSTEES** That the trustees shall have the following powers: to manage all the assets and/or properties of the trust including the conduct of business;

i. to appoint office bearers , employees and to settle the terms of their service, remuneration and termination;

ii. to look into the management of the trust;

iii. to invest the funds of the trust, in bank or in the purchase of company shares or securities or other movable and movable and immovable properties;


iv. to sell, alter, vary, transpose or otherwise dispose or alienate the trust properties or any investment representing the same for consideration and to reinvest the same;

v. to pledge or mortgage the trust properties for raising loans;

vi. to open the bank accounts in the name and on behalf of the trust and to operate the same;

vii. to enter into a partnership on behalf of the trust with any other party or parties;

- viii. to pay all charges, impositions and other outgoings payable in respect of the trust properties and also to pay all cost of the incidental to the administration and management of the trust properties;
- ix. to file suit on behalf of the trust and to refer to arbitration all actions proceedings and disputes touching the trust properties and to compromise and compound the suits filed;
- x. to accept any gift, donation or contribution in cash or in kind from anyone for the objects of the trust;
- xi. to seek legal opinion of lawyers and/or Chartered Accountants as and when required;
- xii. to nominate their representatives for any of the aforesaid purposes.
  - xiii. In case of any difference between the trustees, the matter shall be referred to the settlor and his opinion shall prevail.
  - xiv. Every trustee will be at liberty to nominate or appoint attorneys or agents and to delegate all or any of the duties and powers vested in him to such attorney or agent, and to remove such attorney or agent and reappoint other or others in his place.
- xv. No trustee shall be responsible or liable for any loss or any act of omission or commission by his constituted attorney or agent or employees or other trustees unless occasioned by his wilful neglect or default.
- xvi. Any of the trustees may retire on giving one month's notice in writing to the other trustee(s).
- vii. If any trustee dies or retires or becomes incapable or unfit to act, the continuing or surviving trustee or trustees shall appoint a successor in the place of such trustee.

viii. If at any time the number of the trustees is less than two, the existing trustee shall appoint one or more trustees.

ix. Upon the appointment of a new trustee the trust properties shall vest in the new trustee jointly with the continuing or surviving trustees, with the duties and power of the trustees set out hereinabove in this deed.

xx. If the trust is determined by efflux of time, the corpus of the trust shall be divided amongst the beneficiaries in the shares as fixed by the trustees.

**13. BANKING ACCOUNT** All income, subscription and pecuniary donations for the general purposes of the Trust and the income, investments and all other moneys from time to time forming part of the general revenue of the Trust shall on the same being received be paid into a banking account with any scheduled bank for the purpose of the Trust. The bank accounts shall be operated by minimum of two trustee in joint operation.

**14. ACCOUNTS AND AUDIT** The Trustee shall keep proper books of account of all the assets, liabilities and income and expenditure of the Trust and shall prepare an Income and Expenditure Account and Balance Sheet for every year as on the last day of March.

i. The accounts of every year shall be audited by a Chartered Accountant or a firm of Chartered Accountants who shall be appointed for that purpose by the Trustees and the audited accounts shall be placed at a meeting of the Trustees, which shall be held before the end of the succeeding year.





**WINDING UP** In the event of dissolution or winding up of the Trust the assets remaining as on the date of dissolution shall under no circumstances be distributed amongst the Trustees but the same shall be transferred to some other similar Trust/Organization whose objects are similar to those of this Trust with the permission of the Charity Commissioner / Court / any other law as may be applicable for the time being. The Trustees shall be indemnified against all losses and liabilities incurred by them in the execution of the Trust and shall have a lien over the funds and properties of the Trust for such indemnity.



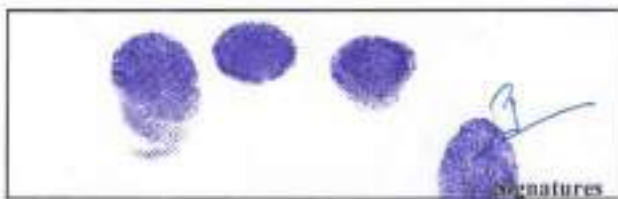
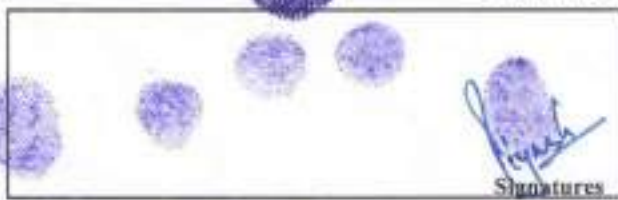
